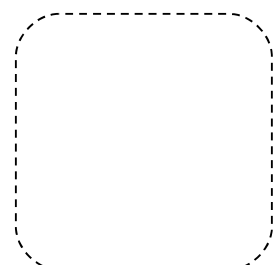

*In return for the British National Party and associated groups providing me with access to information, monies or to property in the course of my duties as an Officer of the Party, I promise the following :*

*▪All ownership of information, monies and property, including intellectual copyright around the fruits of all my work as an Officer of the Party remains with the British National Party in perpetuity. Use of such information, monies or property is only with the permission and at the instruction of the British National Party.*

*▪All information owned by the British National Party and held by me will be done so in the strictest confidence. I will ensure that it is kept in a secure and safe place when not in use. I acknowledge that no information is to be removed from any location, including office premises or stored on any electronic storage devices without due reason and permission and that all external copies of information are to be returned to the British National Party (or securely destroyed as appropriate) once the task is complete.*

*▪At all times I will remain within the constraints of the law in respect of the handling and the use of the information, monies and property. I will allow the use of the information, monies and property only for the purposes for which it was originally gathered or obtained by the British National Party. In particular I recognise the statutory obligations imposed through the Political Parties, Elections and Referendum Act 2000, the Data Protection Act 1998 and the Computer Misuse Act 1990 as well as all other relevant legislation.*

*▪I promise to abide by the British National Party's Constitution, its Code Of Conduct and the Officers' handbook with the acknowledgement that they may change from time to time.*

*▪Once I am no longer acting solely in the role of a Officer of the Party Officer, then I will return all information, monies and property of the British National Party within 24 hours.*

*▪I accept that failure to adhere to the terms and conditions detailed above may result in criminal charges being brought against me.*

*▪I accept that where it can be shown that I have supplied false information or deliberately failed to adhere to the terms and conditions detailed above, that I promise to pay the British National Party a minimum indemnity of £4,500.00 and further accept costs of any and all civil action to recover such information, monies and property and make good any damage caused directly or indirectly by my failure to adhere to the terms and conditions.*

*▪The signing of this form by me as the applicant indicates the acceptance of the terms and conditions above and guarantees that to the best of my knowledge, all information supplied by me is accurate and complete.*
